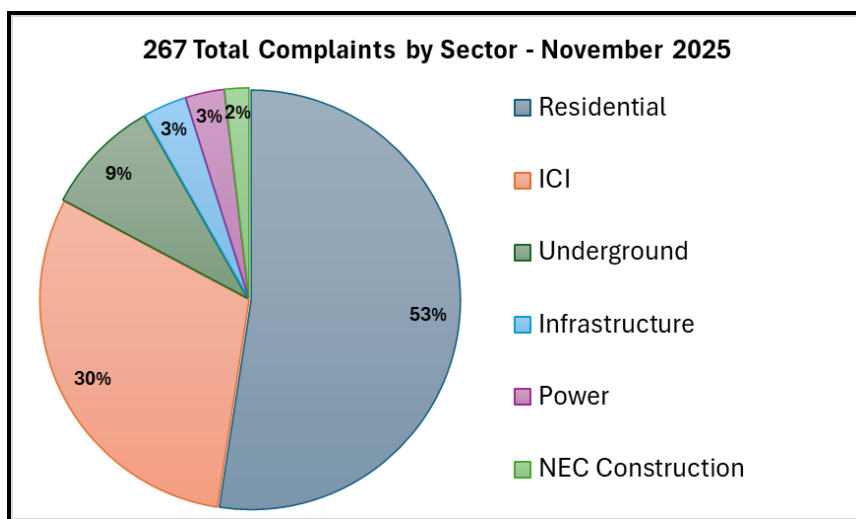
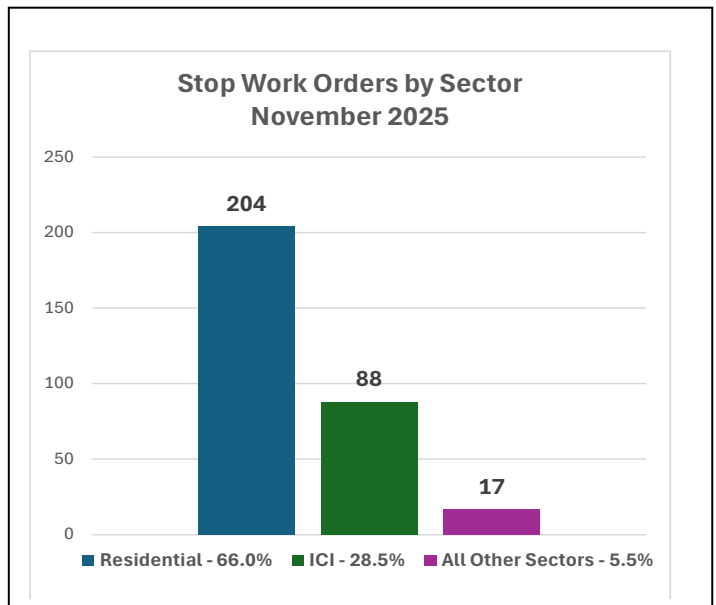

MLITSD Construction Inspectors conducted **1,552** field visits to **1,143** workplaces during the month of November 2025 resulting in **3,420** orders and requirements, which includes **309** Stop Work Orders accompanied by **460** Time Unknown Orders.

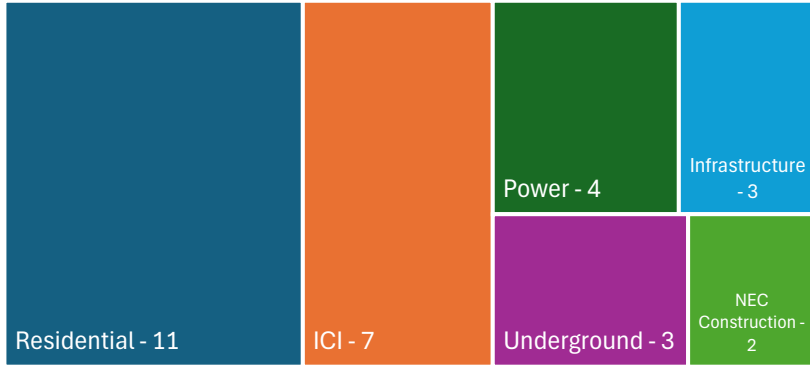
